Application Procedure:

- Nomination form is to be completed and should be submitted to assisecretariat@assi.in with a copy to *Dr. Gautam Zaveri*, Secretary ASSI at secretary@assi.in and *Dr. S. Rajasekaran*, Chairman, Nomination Committee at rajasekaran.orth@gmail.com
- Only life members are allowed to contest / or propose or second a contestant. The number of required years of ASSI membership is according to the post he is applying for.
- Any member of the Nomination Committee should not propose or second the contestant.
- Contestant should submit a short CV of 250 words and short write-up of 250 words regarding how he/she would like to contribute to the growth and functioning of ASSI.

President elect

- Minimum 10 years of life membership including “Value Added Annual Services (VAAS)” membership
- Proposed by 2 life members
- Preferably should have conducted at least one ASSICONS /ICSs in the capacity of Organising Secretary/ Organising Chairman
- Should have been executive member of ASSI
- Should have attended at least 6 of the last 10 ASSICONS/ICSs meets
- Should have attended 6 of the last 10 GBMs

Joint Secretary cum Treasurer

- Minimum 6 years of life membership including “Value Added Annual Services (VAAS)” membership
- Proposed by 2 life members
- Should have preferably conducted at least one ASSICON/ICS in the capacity of Organising secretary/ organising chairman
- Should have been executive member of ASSI
- Should have attended at least 4 of the last 6 ASSICONS/ICSs meets
- Should have attended last 4 of the 6 GBMs

Eligibility criteria for the post of Executive Committee Member of ASSI are as under:

- Minimum 5 years of life membership including “Value Added Annual Services (VAAS)”
- The same EC member cannot be elected for consecutive terms.
- Applicant must have published/submitted at least one original article in ISJ.
- Should have attended at least 3 of the last 5 ASSICONS/ICSs
- Should have attended at least 3 of the last 4 GBMs
- Proposed by 2 life members
- Active participation in ASSI events preferred
- Faculty of the ASSICONS/ICSs preferred
